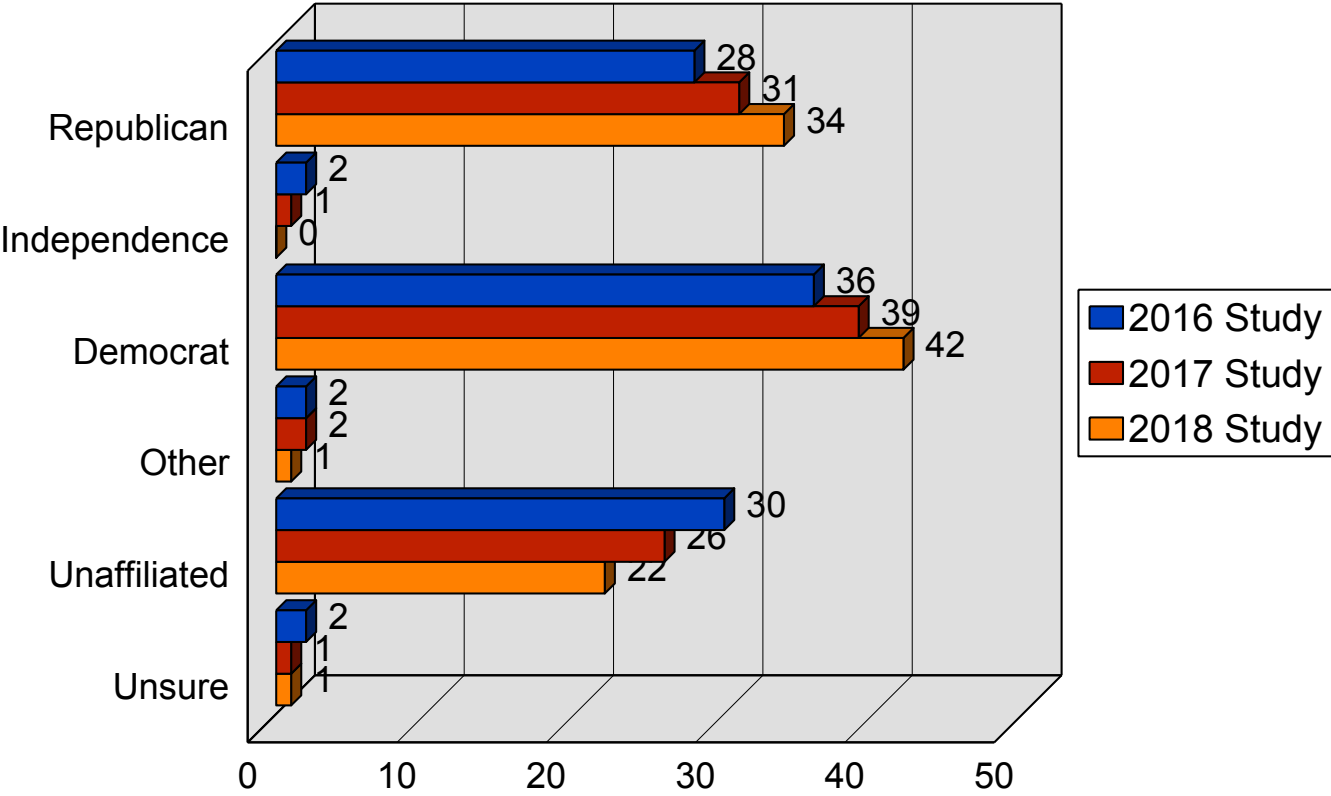

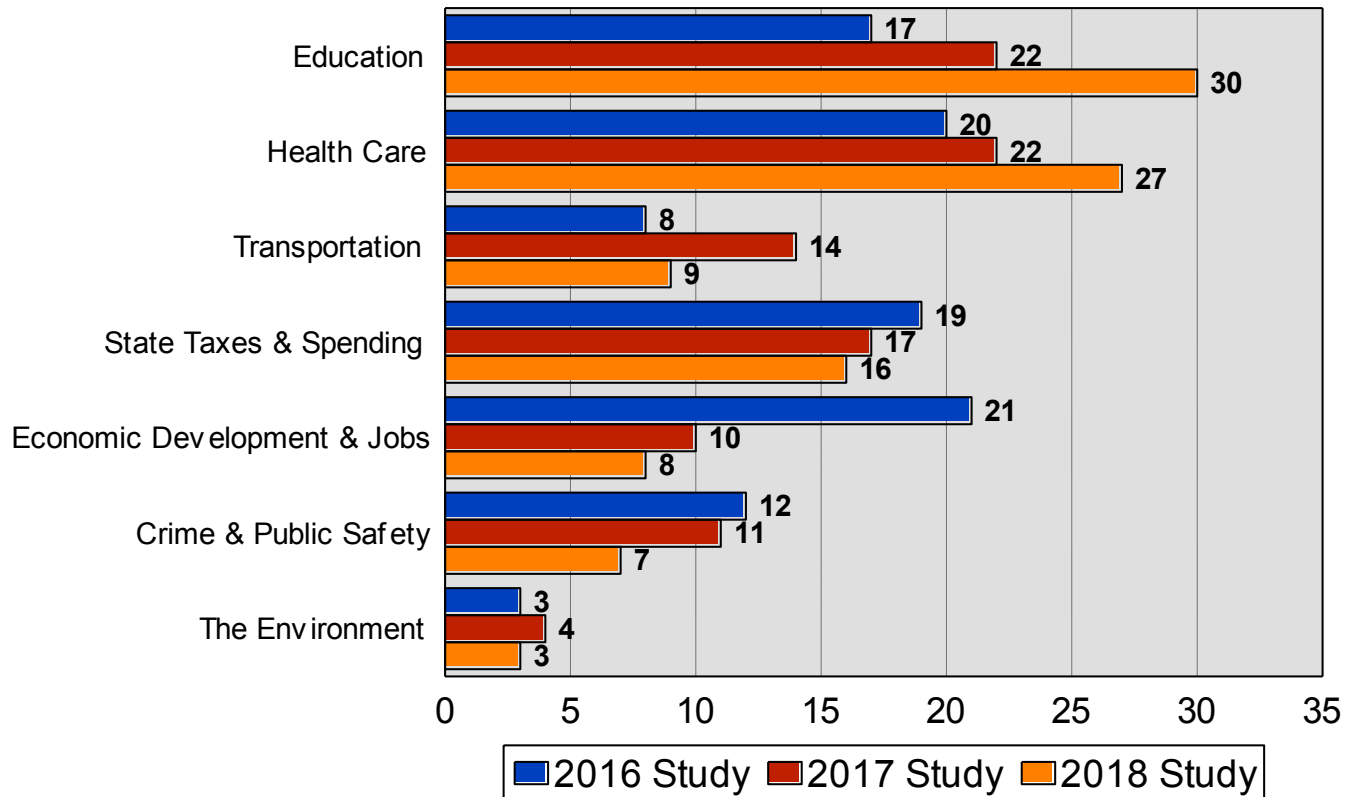

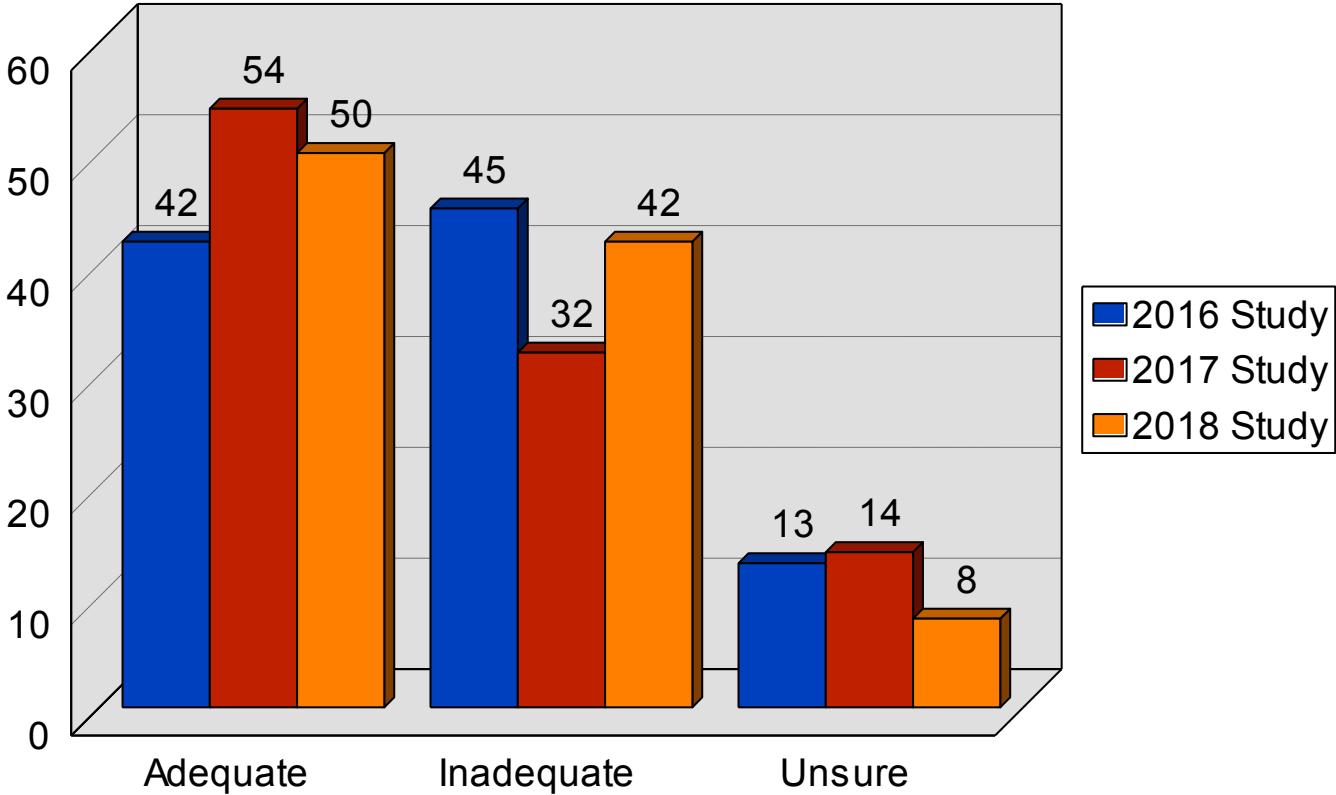

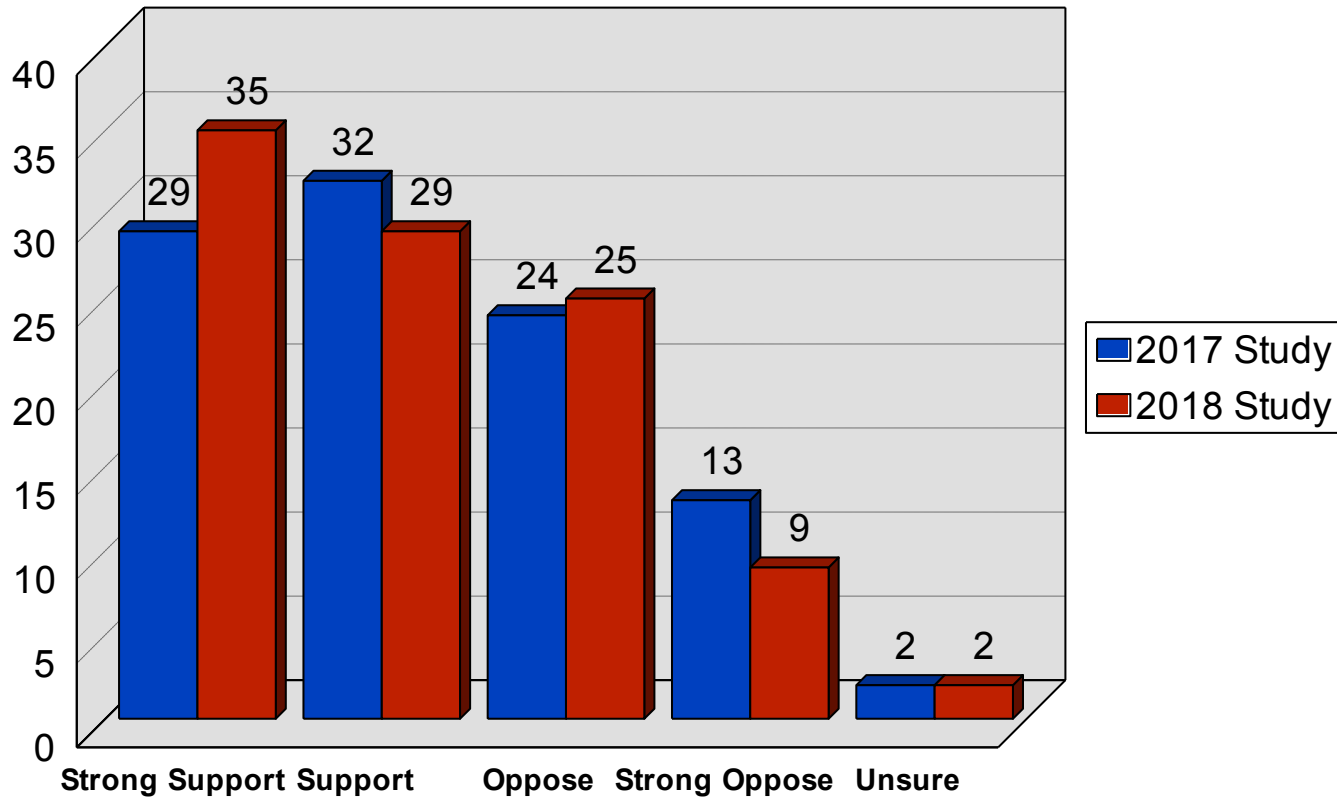

Mandatory Inflation Increase in Education Funding Formula

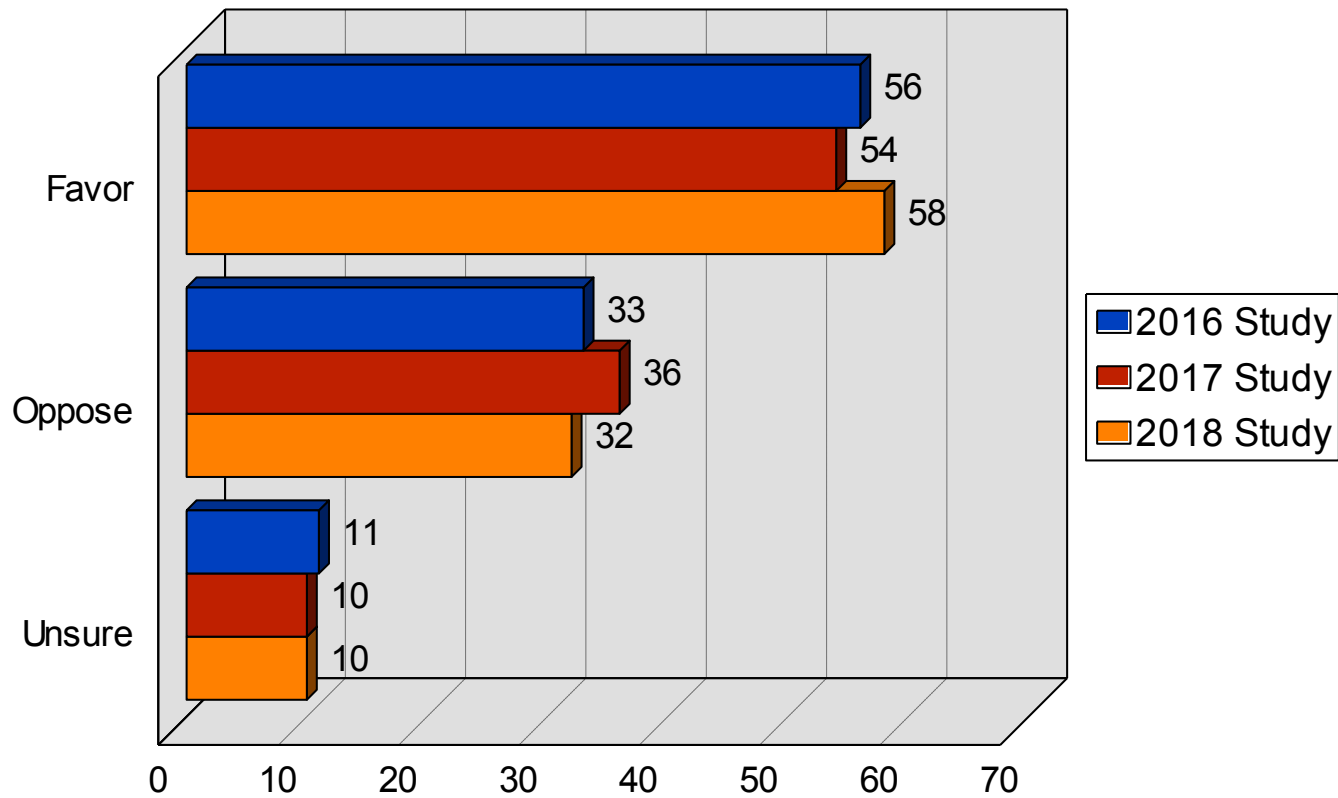

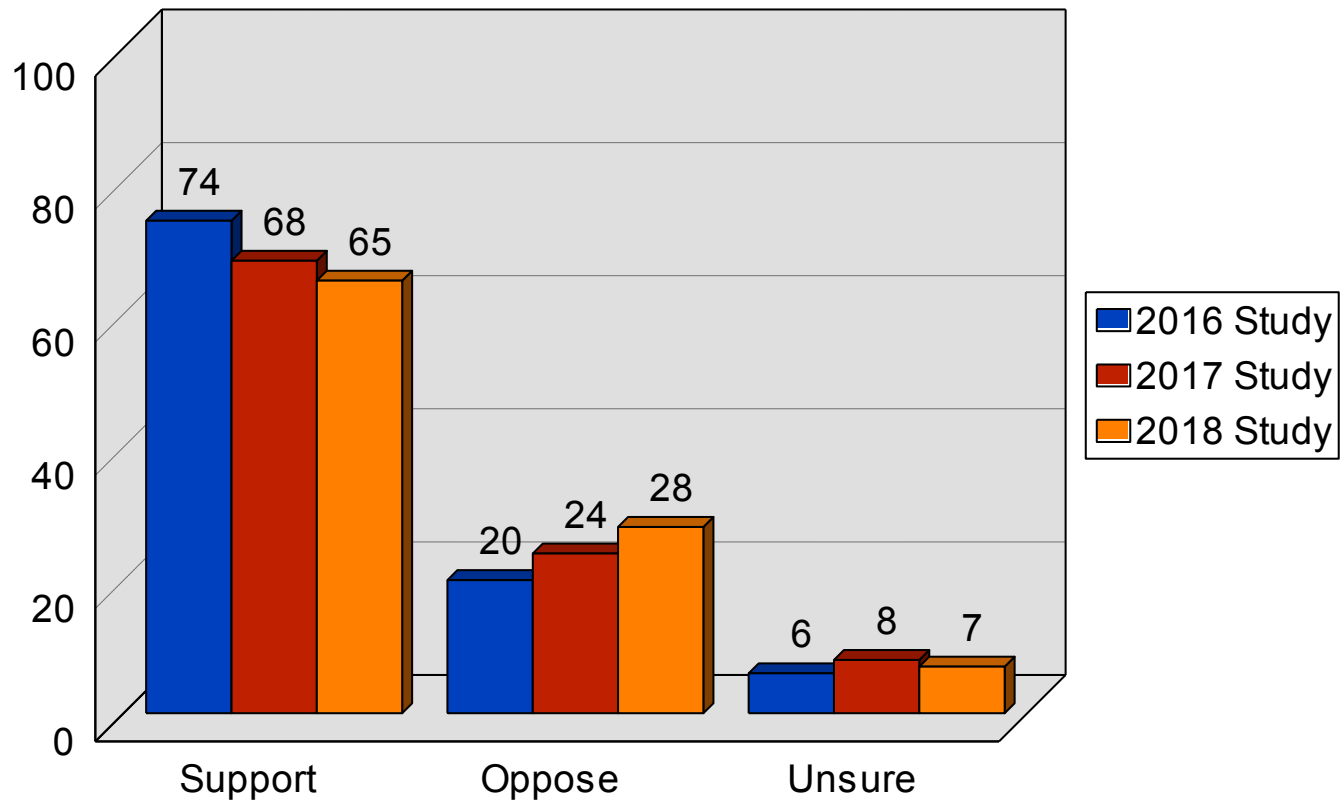

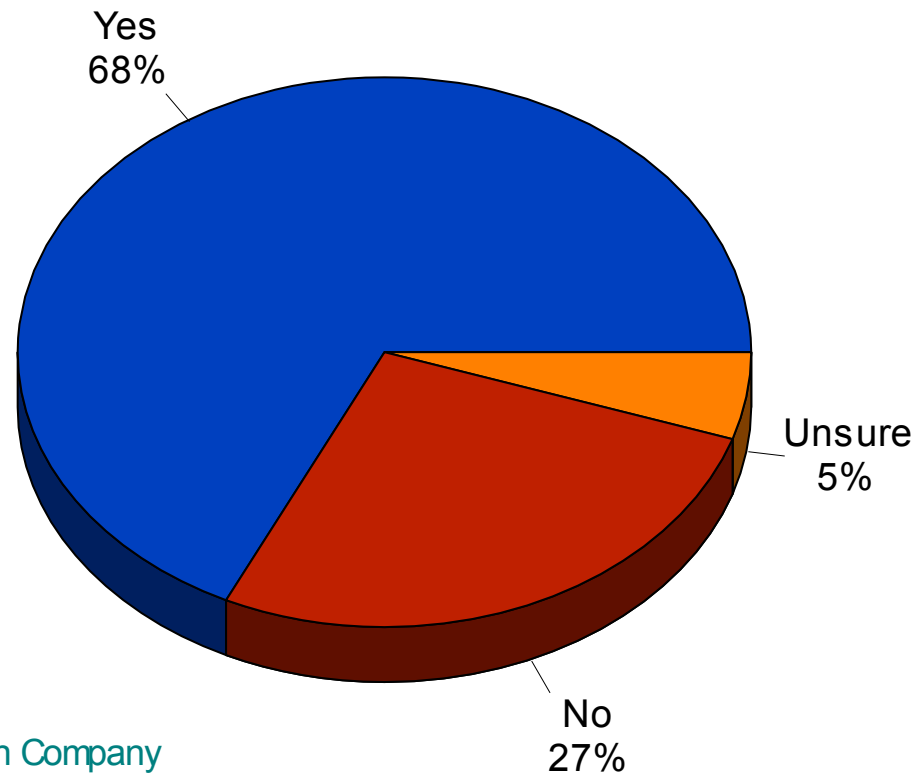

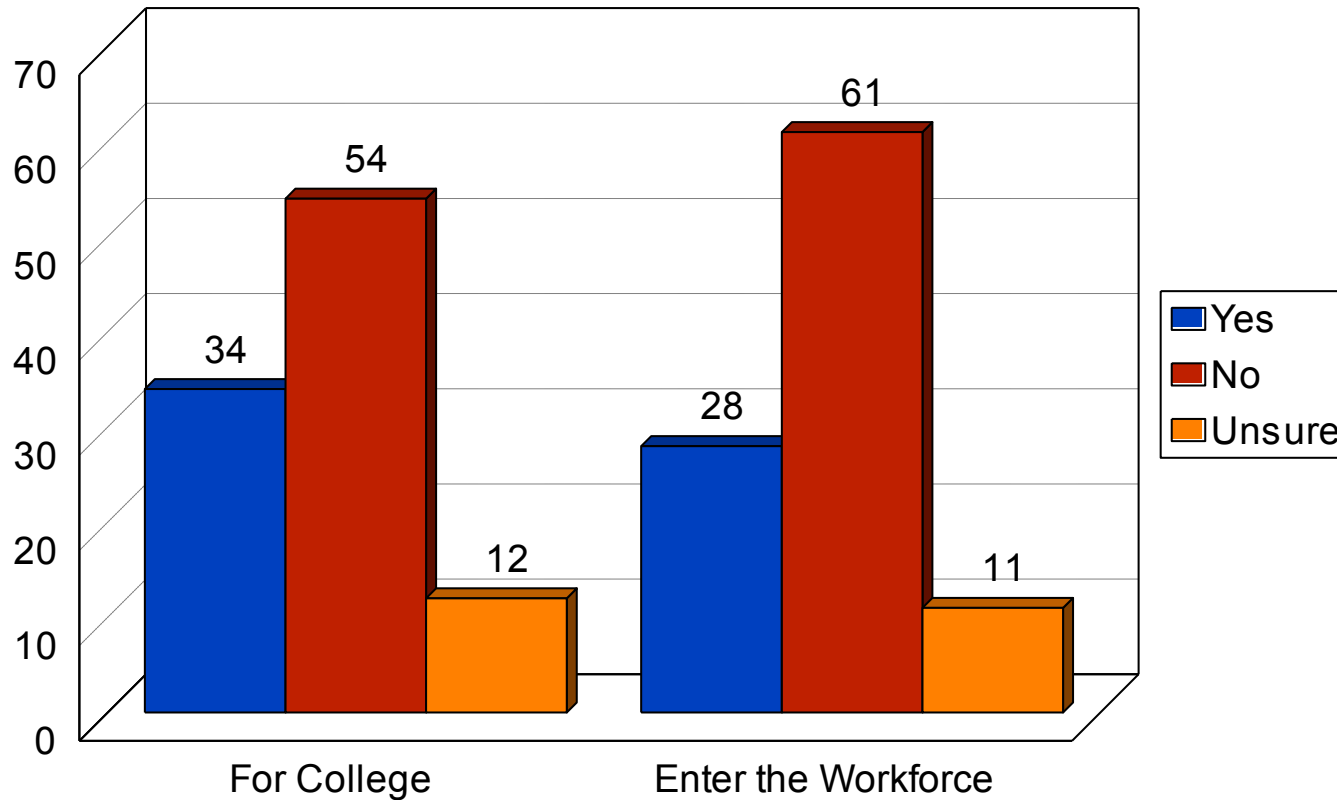

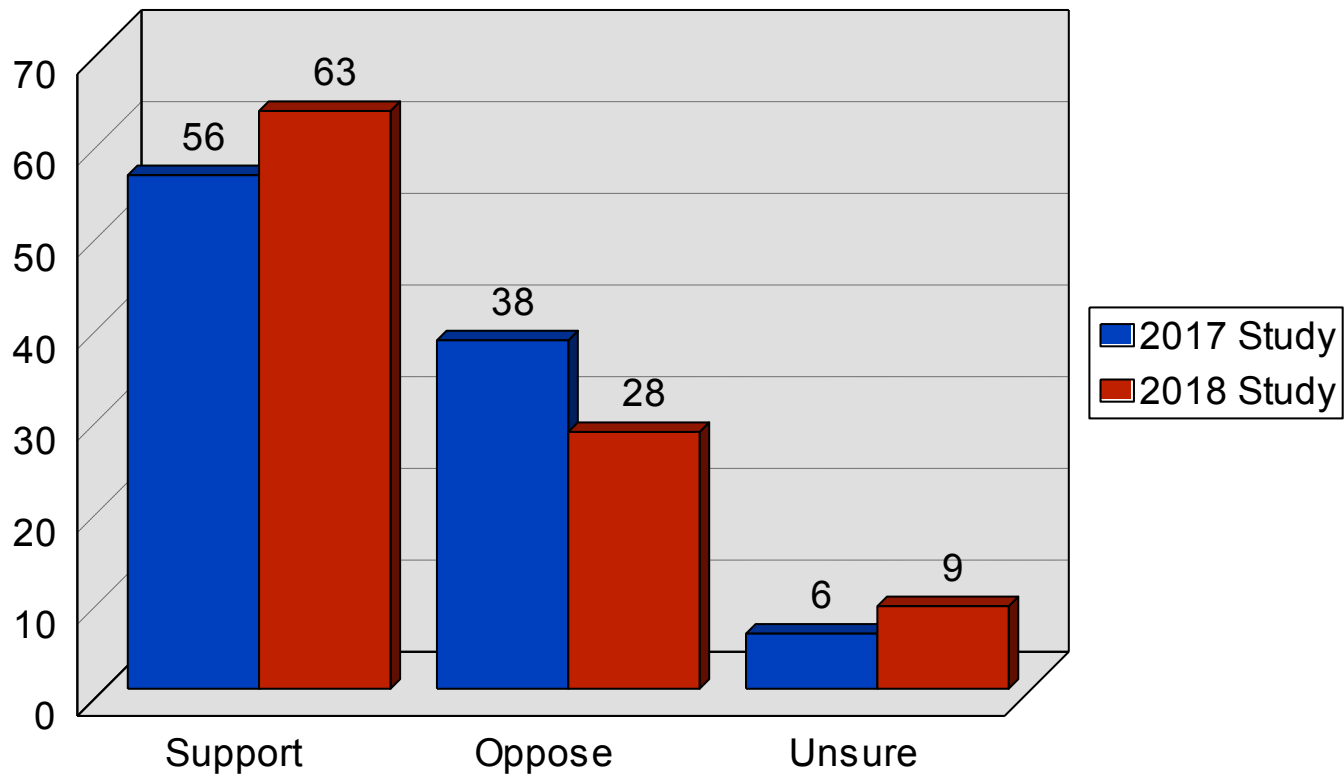

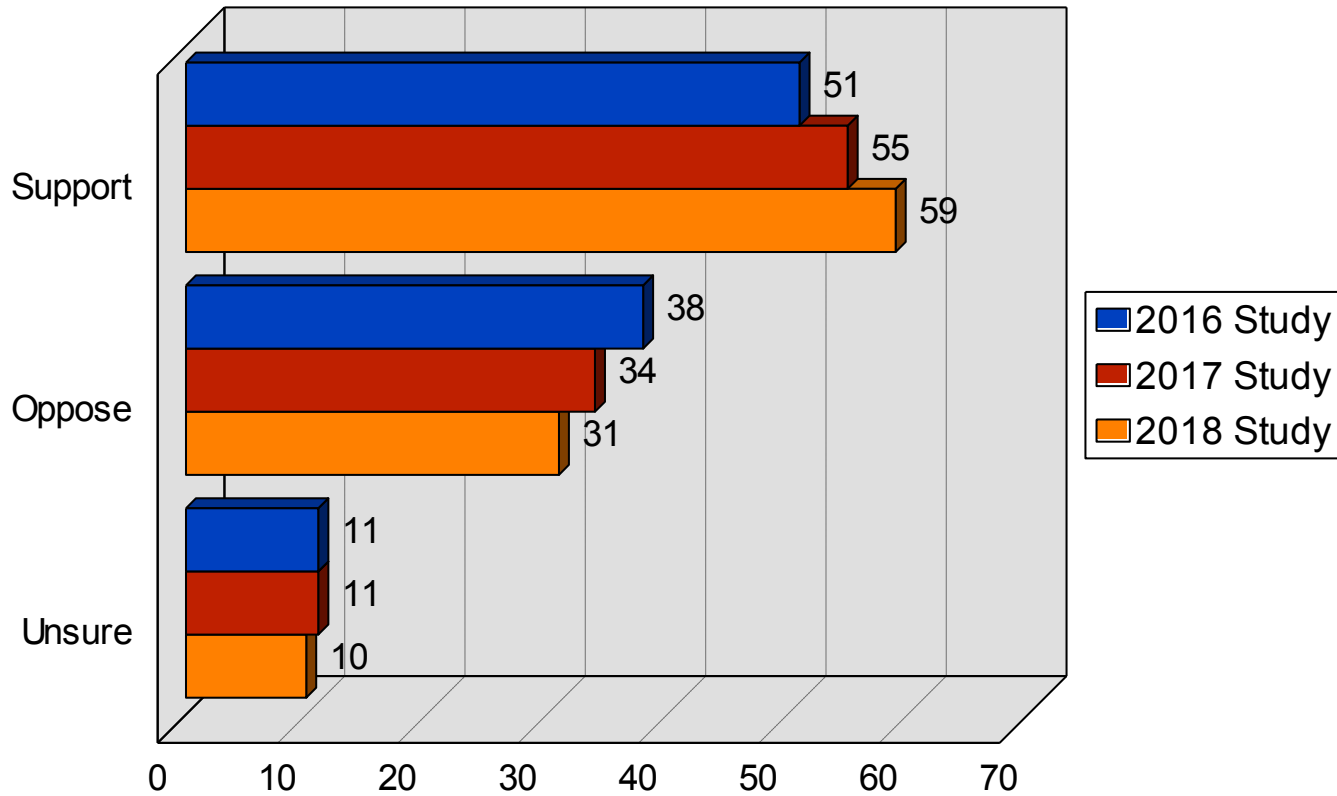

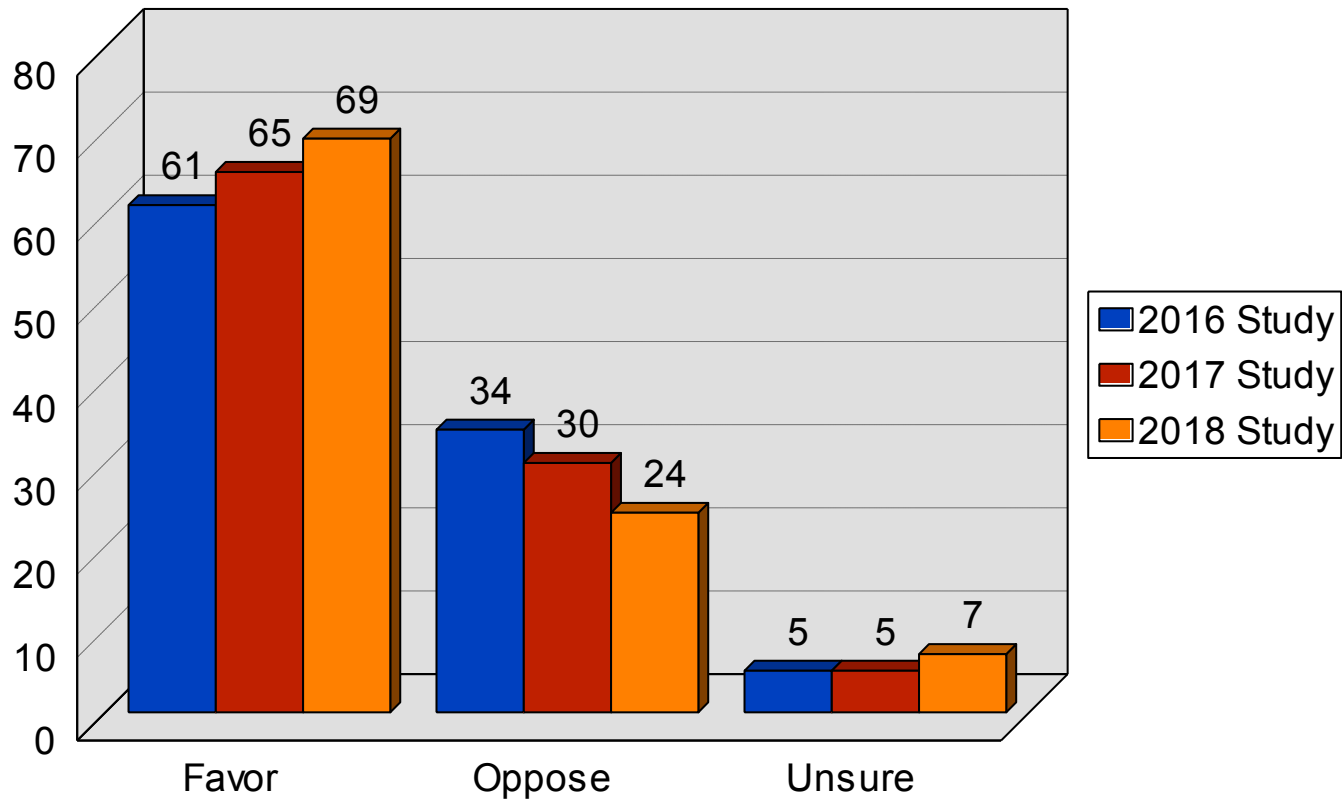

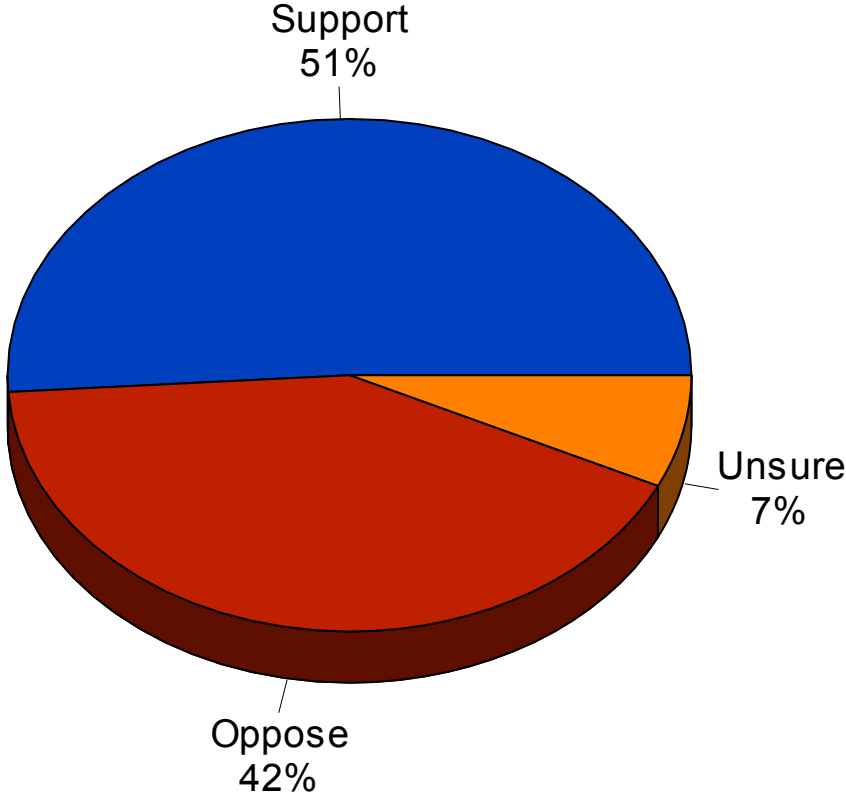

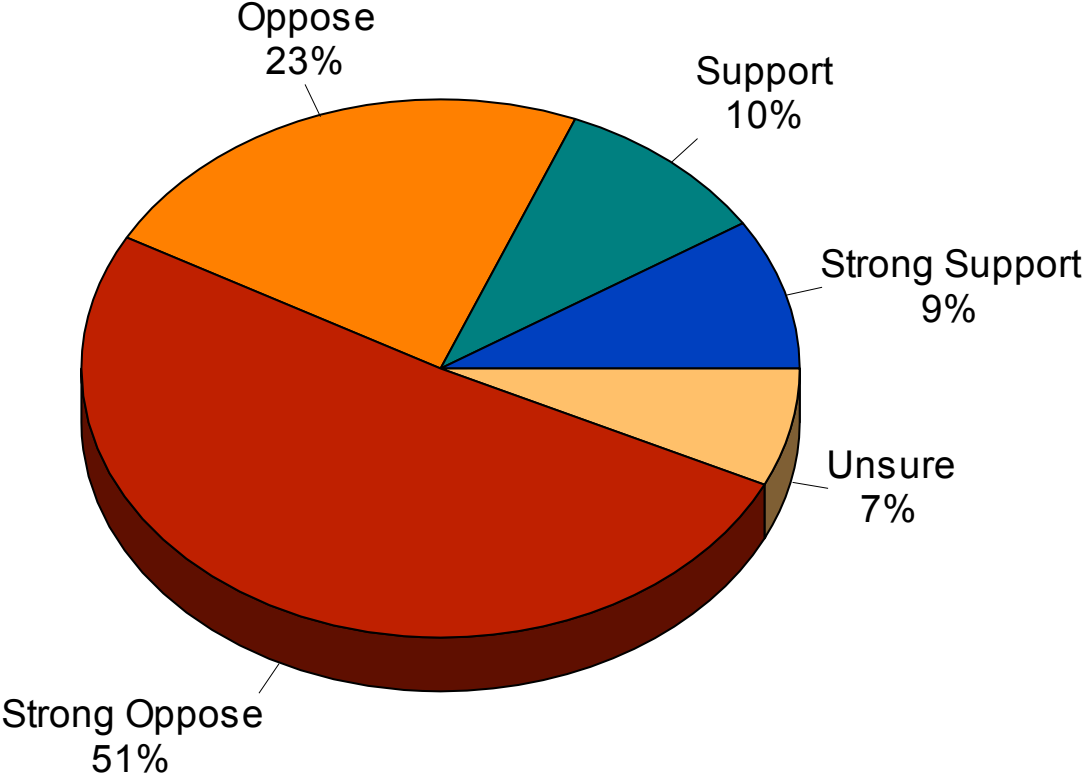

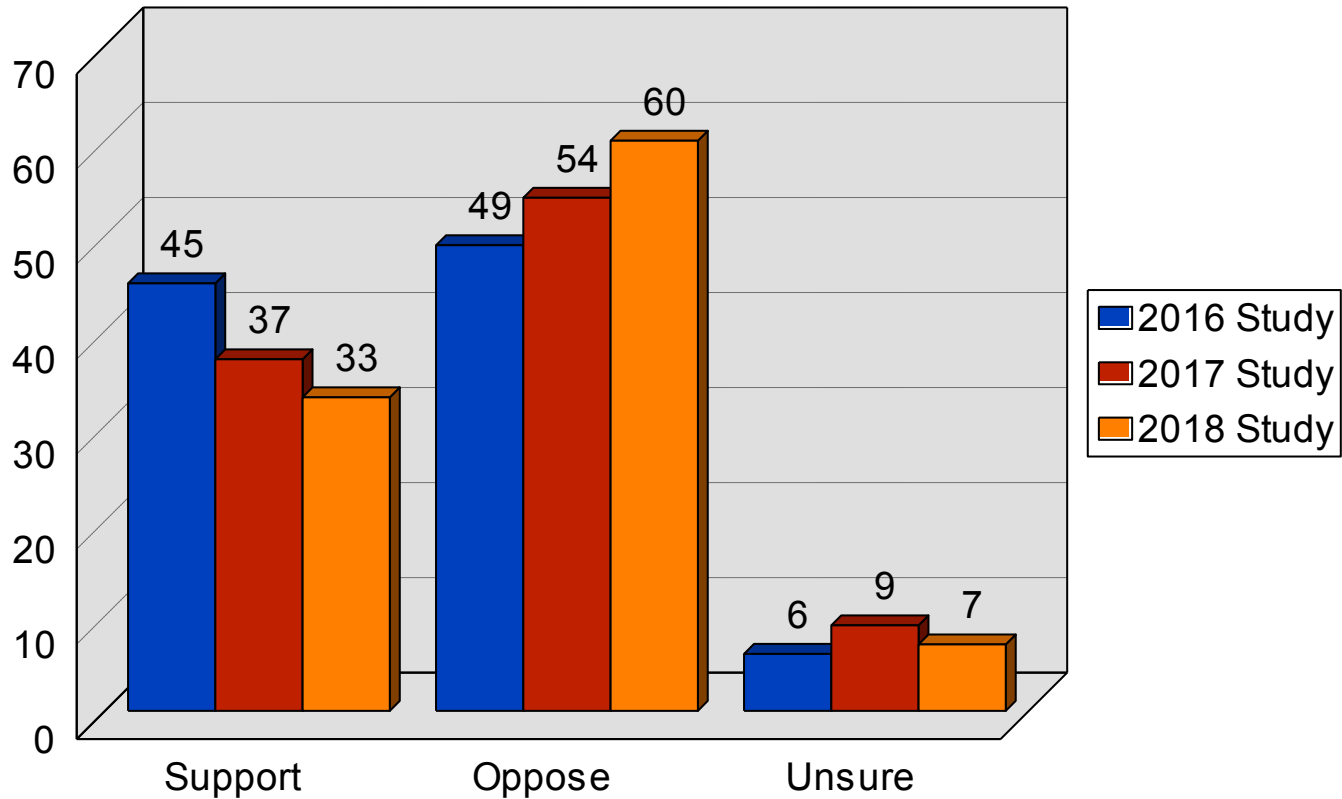

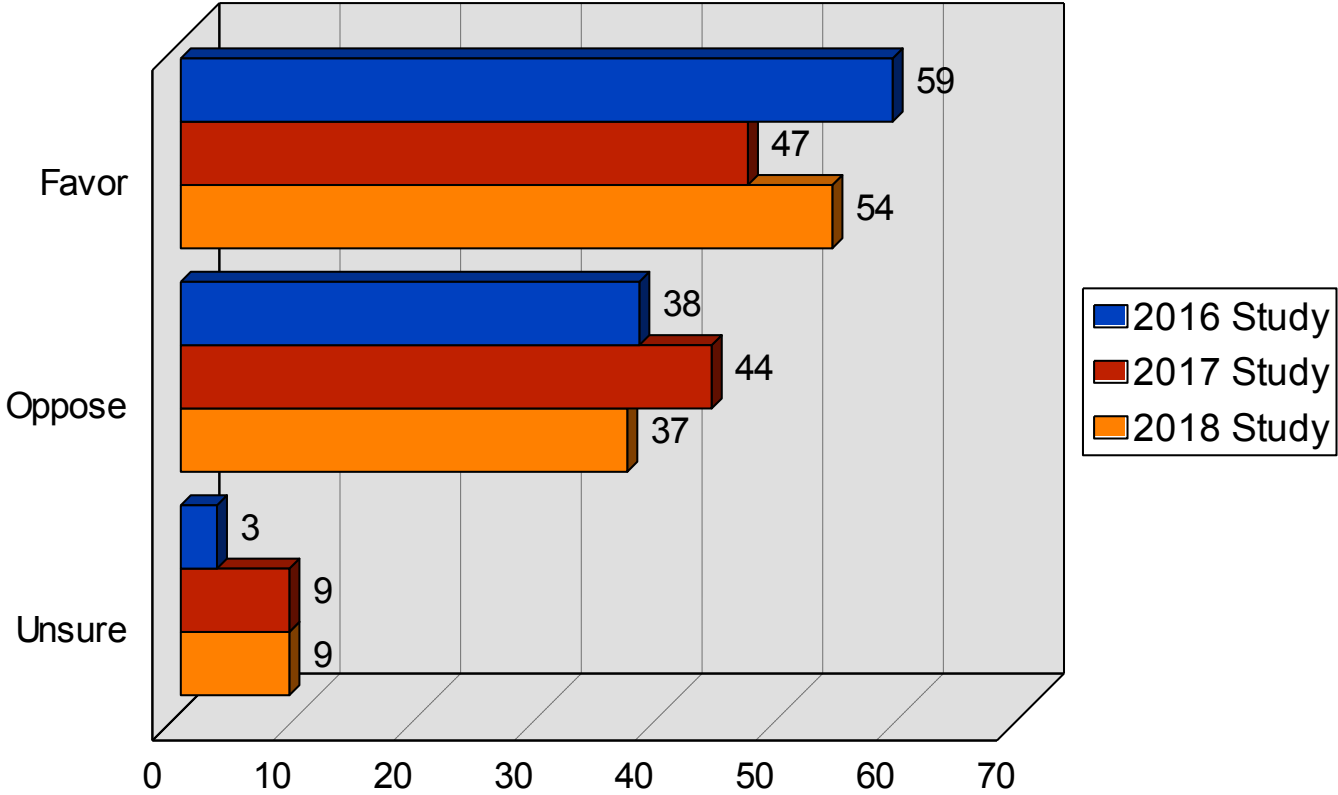

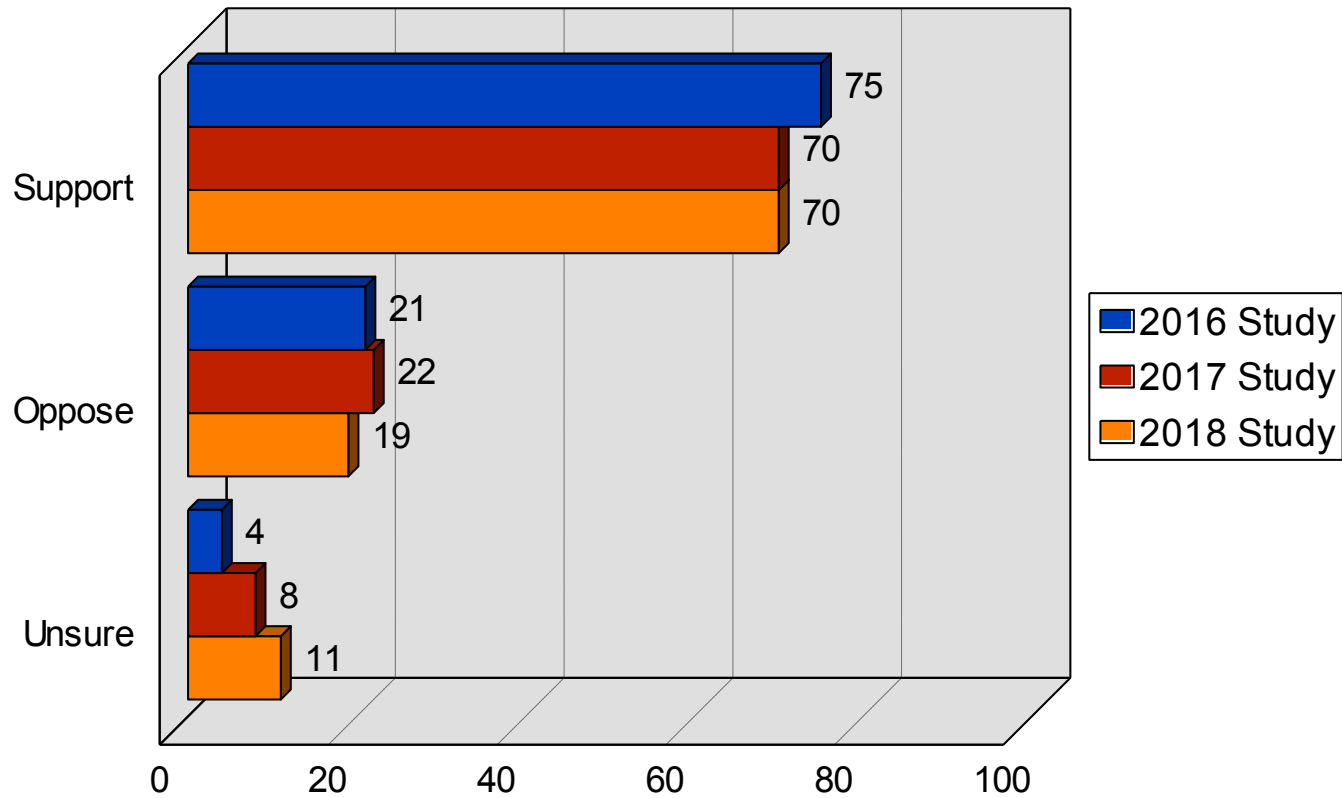

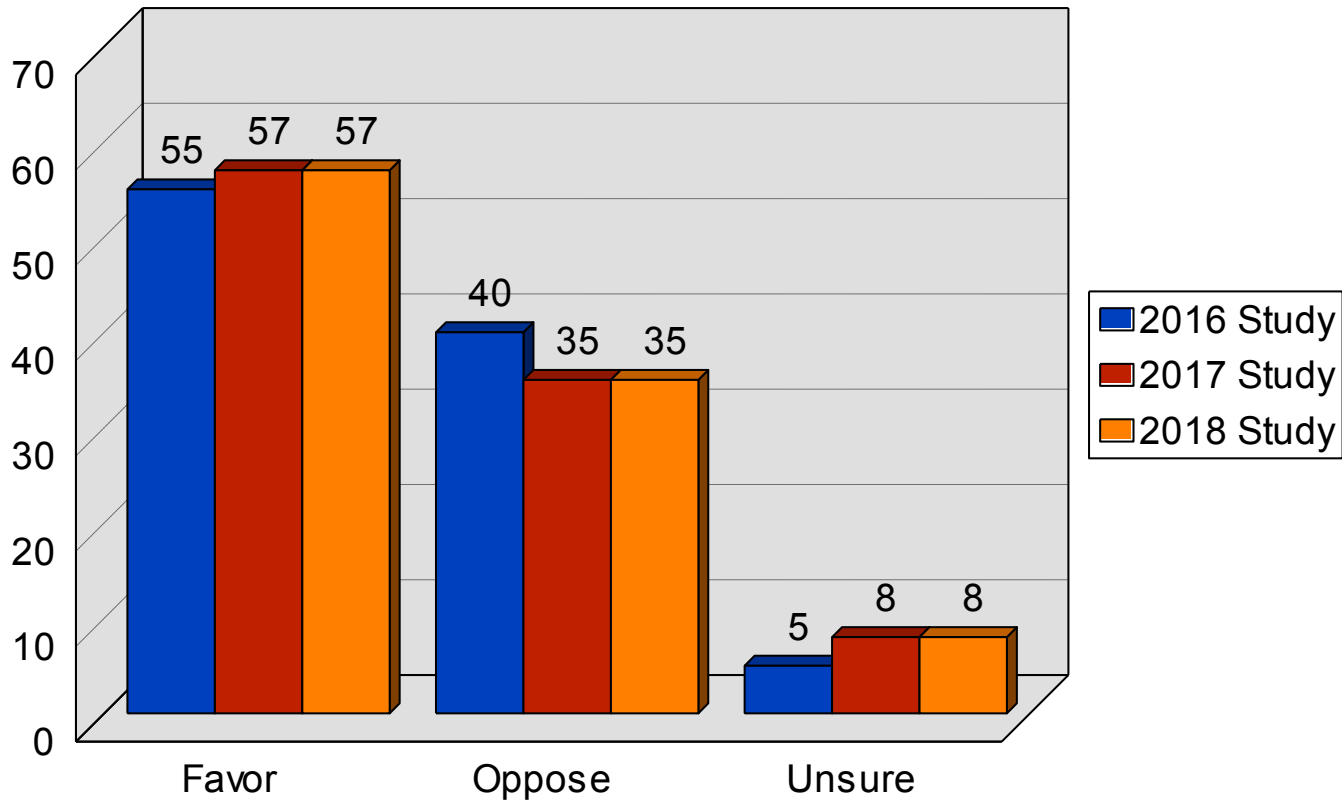

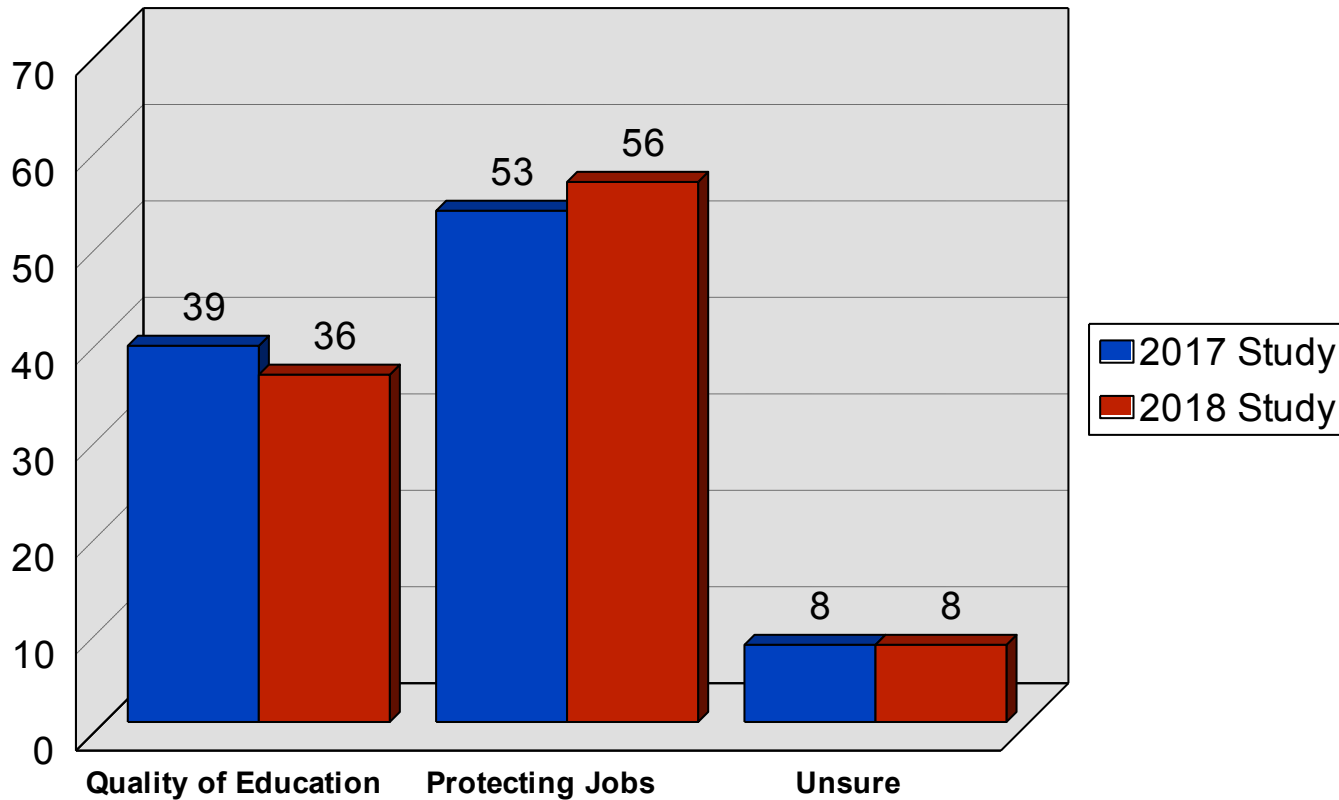

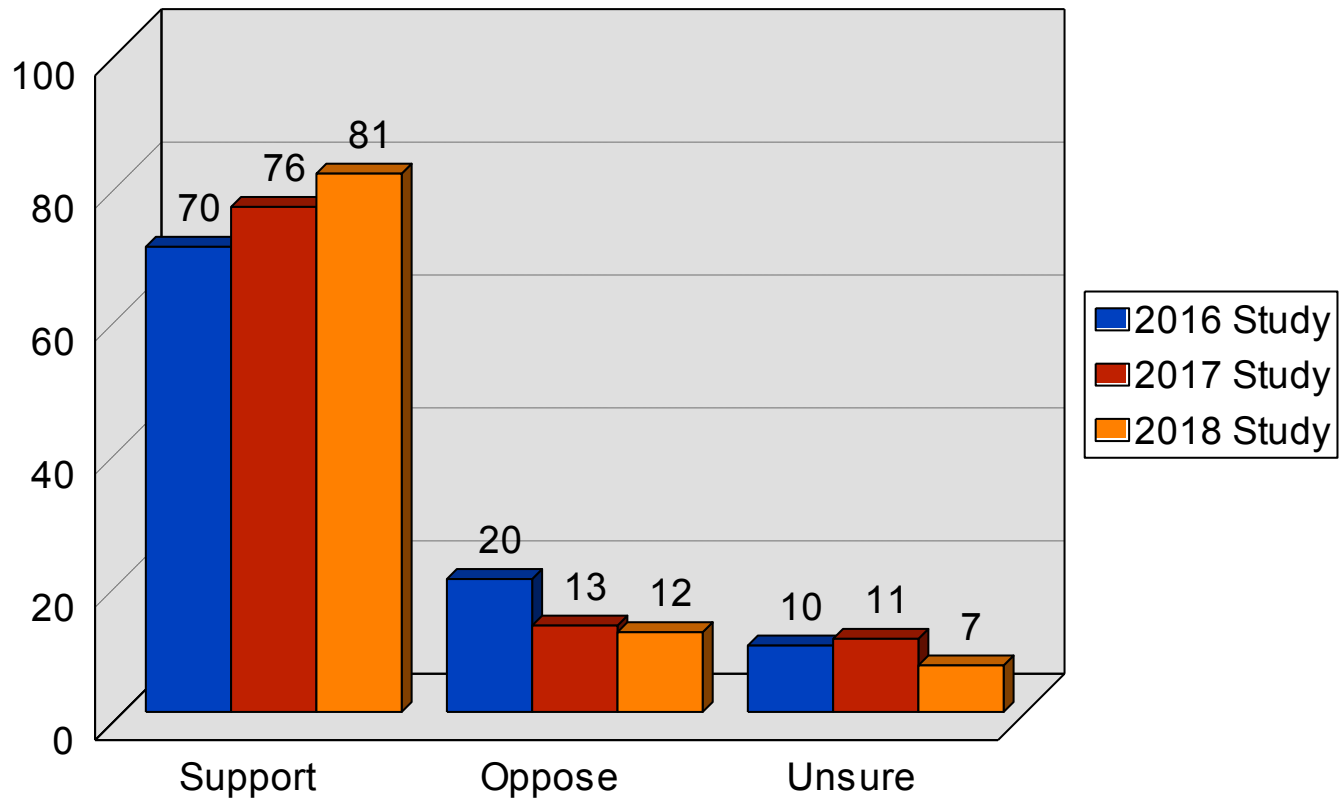

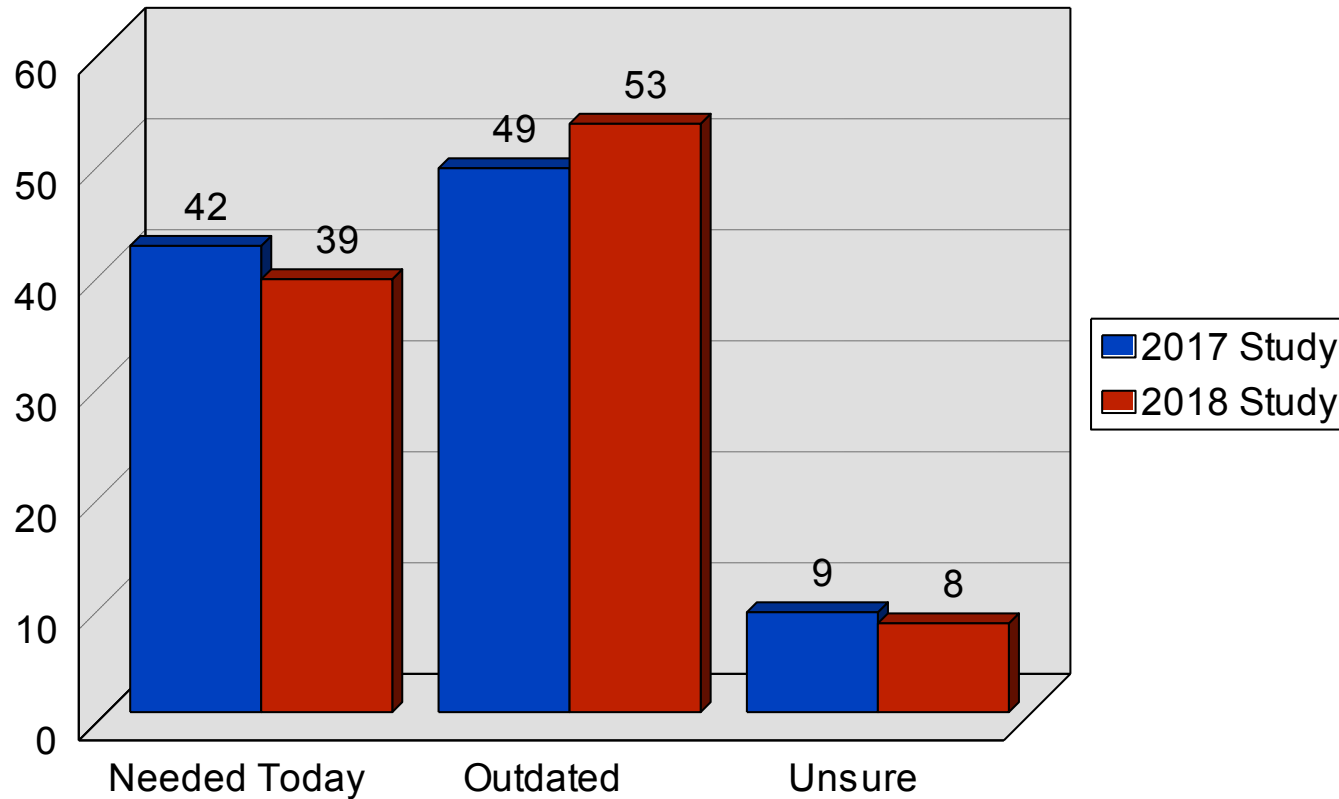

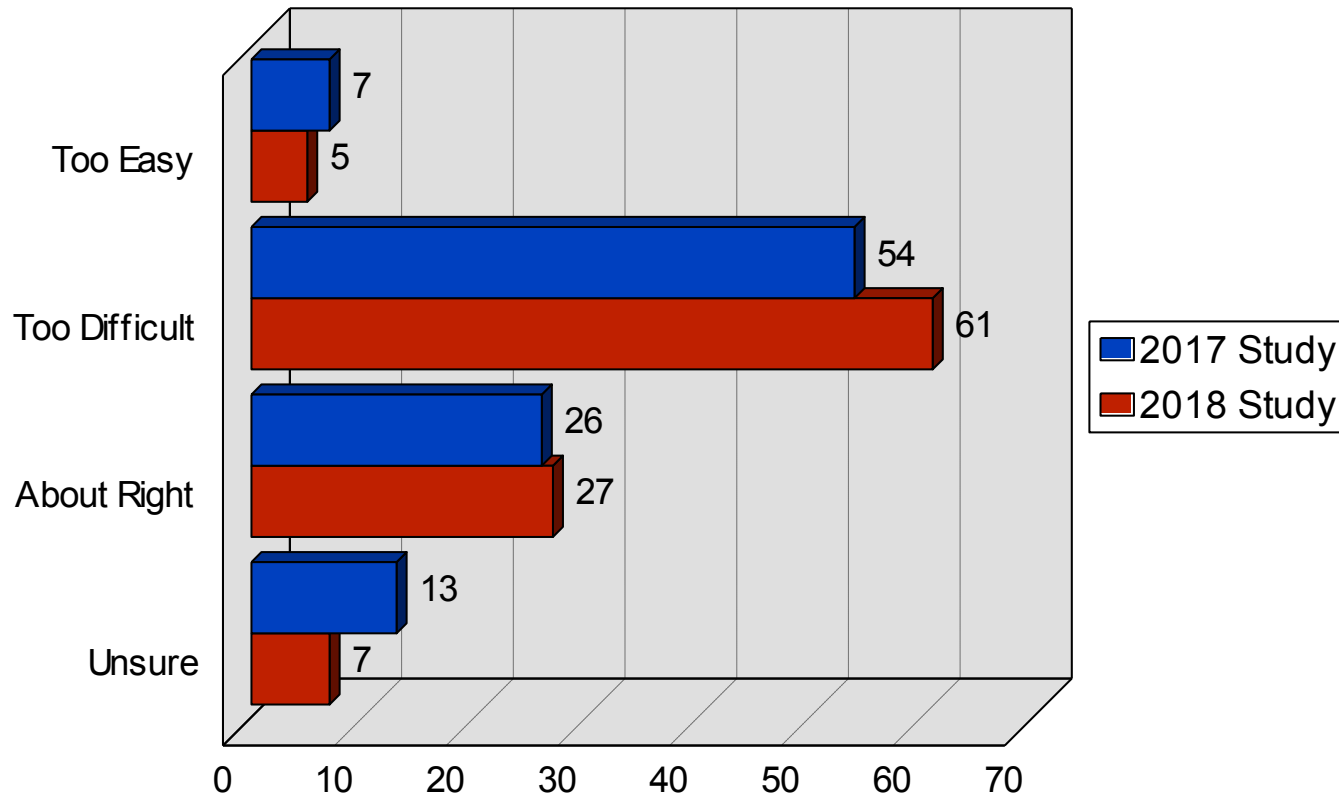

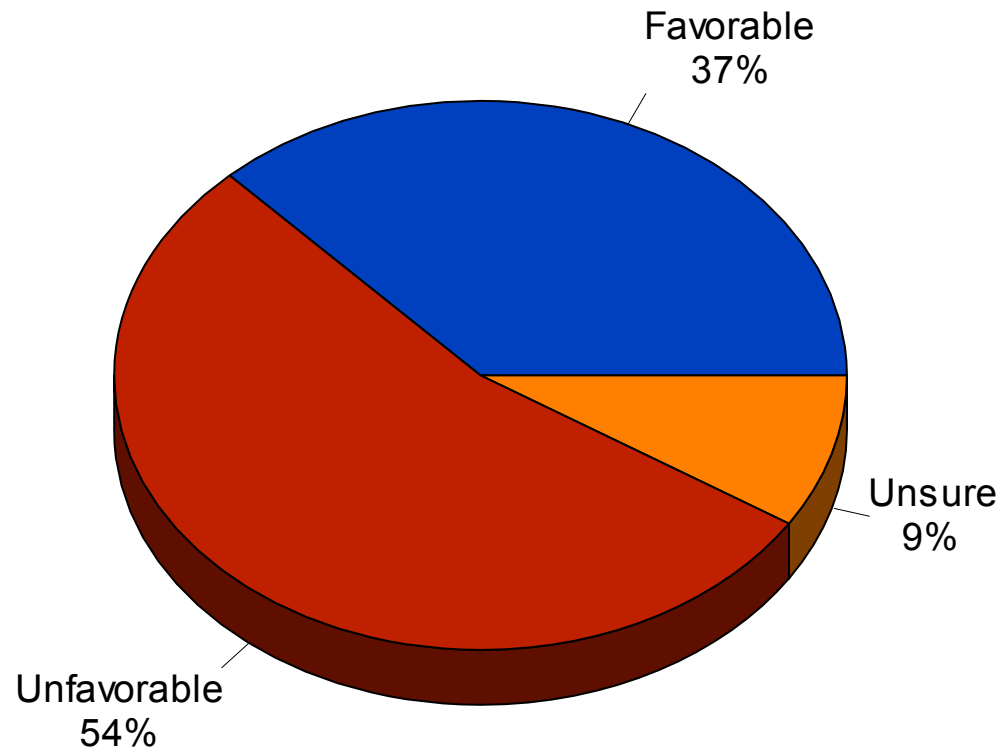

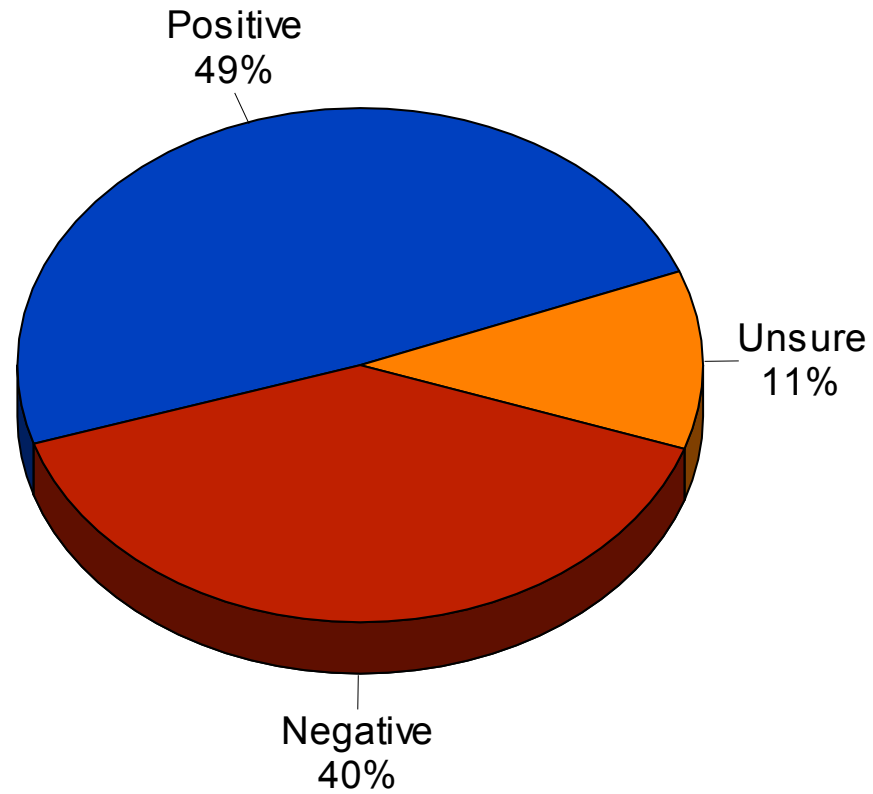
